



Klamath County ARES HF Net Script

Note to Net Control Station ("NCS")

- Check frequency a few minutes prior to the net by saying "Is this frequency clear?" **If not and cannot be obtained, move up 2 kHz** and continue with announcement: This is (your call sign) checking for any emergency or priority traffic on this frequency. There is an upcoming net. If you have emergency traffic please come now, Over. **(If nothing heard)** Nothing heard, out.

Good evening. This is Klamath County ARES HF Net, club call KF7KLA, Kilo Foxtrot Seven Kilo Lima Alpha. Except for the fifth Monday of the month, this net meets every Monday at nineteen fifteen hours Pacific Time on or around 3964 kHz. The purpose of this net is to test the effectiveness of establishing emergency communications as a back-up to our repeater systems and simplex frequency. All stations interested in public service and emergency communications are welcome to help test the system. Oregon ARES members and officers are encouraged to check in to pass on District and Section news, activities and upcoming events. **BREAK**

This is a directed net. Your Net Control Station is Your Call Sign located in City, County; and my name is Your Name. All communications should go through Net Control. Anyone having Emergency traffic may break the net at any time by saying EMERGENCY EMERGENCY. Are there any Emergency or Priority traffic now? **DROP with EXTRA PAUSE** Any relays?

This net has two rounds. The first round will be station check ins. Our normal procedure is to start with any station on short time status. Next will be visitor check ins, first from stations anywhere outside of Klamath County, then within Klamath County. Check-ins will end with a roll call of Klamath County ARES members. The second round of the net will be a round table for stations that have checked in. When called, please share any comments, questions or suggestions you may have for the good of the net. **BREAK**

Visitors, when checking in, please give your call sign only. When recognized, you will be asked for your name, location and your ARES unit, if any. Klamath County ARES members are requested to remain on frequency until after the round table unless excused by Net Control. **BREAK**

This is KF7KLA. I will now accept check-ins from any **station on short time status**. Please call now. Any relays?

Thank you to all short time stations. You are excused to leave the net at your discretion.

Visitors anywhere outside of Klamath County, please call now.

Any relays for visitors outside of Klamath County?

This is KF7KLA. I will continue with **visitor check within** Klamath County. Stations within Klamath County, please call now.

Any relays for Klamath County visitors?

Let's move on to roll call for **Klamath County ARES** members. Roll call starts now

This is KF7KLA calling for any late or missed stations who wishes to check in, please call now.

Any relays?

Proceeding to Round 2 of the net. We will go back to visitors who have checked in. When called, please share any comments, questions or suggestions you may have for the good of this net.

Moving on to Klamath County ARES members. When called, please share any comments, questions or suggestions you may have for the good of this net.

Is there any further business for Klamath County ARES HF Net before I secure the net?
